Treasurers Report:

The Audited Statement of Account for the year ending 30th April 2017 was issued showing the accounts stand at: Business Saver Account £2,266.33, Community Account £681.55 and Cash £142.11 being a total of £3,089.99. This included £90.00 paid on account for the Champion of Champions that fell in May 2017. The overall profit for the year was £357.68.

The Treasurer highlighted the level of fees enabled the League to run without making a loss and also the six counties showed a similar profit to the previous year.

Acceptance of the accounts as presented was proposed by Hertfordshire, seconded by Suffolk and agreed by all counties.

The Treasurer wished to record her thanks to Karyn Chivers for auditing the accounts.

6. League & Tournament Secretary's Report

7. Election of Officers & Auditor

8. Fees

Firstly, the Treasurer gave a forecast for next season which covered:

League - based on the number of league home matches for each county and the cost of their hall hire, a small profit was predicted.

Champion of Champions – this event has taken place and a loss of £5 was confirmed. Due to the number of players taking part in this event, it is not expected to make any profit.

Six Counties – based on the last two years, it is expected to be similar in profit.

Insurance – it is expected to see an increase similar to previous years.

From the above forecast, the Treasurer proposed that all fees remain the same. These being Annual Subscription £60.00 per county, all other fees £3.50 per player.

All counties were in agreement for the fees to remain the same.

It was reminded the Annual Subscription is due for payment by the end of July and the League Fees payable in advance by the end of October.

9. Proposal re League Matches

The proposal from Bedfordshire that at League Matches the home team play with black woods was seconded by Cambridgeshire. All counties were in agreement.

The Rules relating to Eastern Counties CBA Events will be updated and reissued.

10. <u>Dress Code at Champion of Champions</u>

The Dress Code at the Champion of Champions was raised, as there was players not adhering to the dress code.

It was pointed out the dress code is shown on the programme so all players are aware. To highlight this on the programme it was suggested the wording to be printed in bold or a different colour.

With various suggestions put forward that would be difficult to implement, it was decided to leave it to the counties to make sure their representatives adhere to the dress code.

After discussing this matter, it was agreed that in future if a player is in clear breach of the dress code rules, that player will be excluded.

With all counties in agreement, the Eastern Counties Champion of Champions next year will be put back a week to 20th May 2018. All future dates remain the same.

ii. Singles Markers at Teambowl

Norfolk gueried on who should be markers for the singles at the Teambowl.

It was advised that it was relied upon volunteers but all counties are to encourage their players to carry out marking and to make sure their players who mark appreciate the rules.
